ADDITIONAL INSTRUCTION PLEASE READ CAREFULLY

Given the limited number of permits, the allocation of parking permits (day permits) is done on a comparative basis of applications. This allocation therefore depends on the applications submitted, the number of permits available and the following eligibility criteria:

1. Having a driver license.
2. Being a FULL-time graduate student.
3. The application form must be submitted by the deadline specified in the email.
4. Permits will be distributed according to one of the following requirements:
 - 1) The distance between the home (university address) and the School will be confirmed by the driver's license (photocopy accepted) plus proof of residence, for example: (invoice from Hydro-Québec, Bell, photocopy of the lease, etc.) on which your address is listed. **YOU MUST PROVIDE COPIES OF THESE 2 SUPPORTING DOCUMENTS WITH THE APPLICATION**
 - 2) Travel time with the public transport service between the place of residence and the École Polytechnique de Montréal.
 - 3) The family situation :
 - + approximately 10% of the permits available will be awarded to students with the following family situation (while observing criteria 1, 2 and 3);
 - + the student has young children (at least 2) attending daycare (5 years and under);
 - + the student has at least one child attending daycare or at least one child enrolled in primary school (priority is given to families with young children (under the age of 5 in daycare);
 - + give a copy with the permit application form:
 - ❖ of the birth certificate,
 - ❖ of the document confirming enrollment in the daycare (and / or the School; otherwise the application is rejected).
5. The list of permits granted will be posted 5 days after the deadline for bringing the form to the AÉCSP premises. It is the student's responsibility to check their email or on the list if their name appears. **The persons whose names will be posted will have 5 working days (starting at the date the list has been posted) to purchase their license at room C-337.1.**
6. **ANY INCOMPLETE REQUEST IS DISMISSED** (missing information).
7. **ANYONE MAKING A FALSE REPRESENTATION WILL HAVE HIS PARKING LICENSE SUSPENDED, FOR THE CURRENT YEAR AND SUBSEQUENT YEARS, AND WITHOUT ENTITLEMENT TO A REFUND.**

N.B. Given the limited number of permits, not all applications will be granted a permit; parking is a privilege that is not transferable from one year to the next; the Committee reserves the right to verify the validity of all the information provided; only cash, checks and debit / credit cards are accepted.
